The Spring Skate Festival Competition is open to all eligible skaters who are members in good standing with US Figure Skating or Skate Canada.

US Figure Skating rules for non-qualifying competitions, as set forth in the 2023-2024 US Figure Skating Rulebook, shall apply. All events will be judged using the 6.0 judging system.

### **ELIGIBILITY**

#### Singles: Excel and Well-Balanced Events:

- Skaters must meet at least the minimum singles test requirements for the event's level. A skater's singles test level may be higher than the minimum requirement.
  - Skate Up: skaters may skate up one level higher than their minimum test requirement allows.
- Skaters may not register for an event level lower than allowed by their competitive floor. An athlete's competitive floor is set by one of the following scenarios:
  - If an athlete has a paid EMS series application for the NQS series, the event level registered for in the most recent NQS will become the lowest level they may compete at in any U.S. Figure Skating sanctioned event.
  - If an athlete has a paid EMS series application for the Excel Series, the event level registered for in the most recent Excel series will become the lowest level they may compete in any Excel event. For Well-Balanced and Specialty events the skater will be permitted to register at one level lower than the "floor" set by their excel series entry.
  - If an athlete has never had a paid EMS series application in the NQS or Excel series, the athlete may select their level based on their goals and technical skills as long as the minimum test requirements are met.
- Skaters are not permitted to enter an Excel free skate and a Well-Balanced free skate event at the same competition (example: Juvenile Girls Free Skate and Juvenile Girls Excel Free Skate). However, they are permitted to enter an Excel and a Well-Balanced event of different types such as a short program (if stand-alone event option), specialty or showcase events (example: Intermediate Women Short Program and Intermediate Women Excel Free Skate).

#### COMPLIANCE:

#### COACHES:

To be an eligible coach at a nonqualifying competition, coaches must meet the applicable compliance requirements and verified by U.S. Figure Skating. Coach compliance falls into two categories, Coach Compliance (includes choreographers) and Learn to Skate USA<sup>®</sup> Instructor Compliance. Details regarding compliance requirements can be found <u>HERE</u>. All compliance requirements must be met at the time of check-in to access the competition, no exceptions.

<u>Coaches of foreign athletes:</u> If you are a coach of a foreign athlete only, you are not subject to U.S. Figure Skating coach compliance and will only be asked to provide a letter of good standing for the federation your athlete represents.

#### **MANDATORY ATHLETES:**

Athletes age 18+ as of the competition start date who will be competing on a team (i.e., synchro, ice dance, pairs, shadow dance, theatre, etc.) with at least one Minor Athlete must complete SafeSport<sup>™</sup> Training. \*

Minor athletes who turn 18 mid-season are encouraged to seek parental consent to take the online SafeSport<sup>™</sup> Training early to avoid any disruptions in their ability to participate as the training is required upon turning 18. The athlete will not be compliant until they have completed the training and their Members Only portal reflects completion. Please email <u>skatesafe@usfigureskating.org</u> for instructions or questions regarding parental consent.

#### **REGISTRATION INFORMATION**

Payment must be made at the time of registration by <u>credit card only</u>. Each transaction includes a 3% transaction fee. Secure online registration and credit card payment is available with Entryeeze at <u>www.skatingclubofwesternnewyork.org</u>

Please be sure you have checked the correct boxes while registering. If you incorrectly mark a box that results in the event needing to be changed, you will be assessed a \$20 fee per changed event.

Please Note: There will be a service charge assessed of \$35 for all credit card disputes.

Registration Deadline: 4/1/2024 at 11:59pm ET OR WHEN THE MAXIMUM CAPACITY OF 300 SKATERS HAS BEEN REACHED. If space permits, applications <u>may</u> be accepted after this date with the chairperson's approval only and a \$30 LATE FEE WILL BE ASSESSED. \*The host club reserves the right to close registration at any time if event capacity is met

#### PARTNERED EVENTS:

Only one partner will complete registration for the team. During the registration process, you will be asked to identify your partner and verify their test information. The registered partner will be responsible for managing all aspects of the competition for the team including music/PPC upload, practice ice sales, etc. Entry fees are as follows:

# MUSIC SUBMISSION/UPLOAD:

All events requiring music must be submitted electronically via the online registration system by the deadline of April 15<sup>th</sup>, 2024 @ 11.59pm

- File Format: MP3
- Bit Rate: 192 kbps or higher and Sample Rate: 44,100 kHz
- This will be verified by the music chair and they may request you upload a corrected file.
- Leaders and trailers (the silence or "dead space" before and after the actual start and end of the program music) may not exceed two (2) seconds. We prefer that there be NO leaders or trailers at all. Excessive leaders and trailers may disrupt the playing of the music during competition.

Competitors must also have available a backup copy of their competition music on a cell phone and it must be immediately available rinkside whenever the skater competes. If the phone does not have the standard round headset connector, an appropriate adapter, such as an Apple Lightning connector or Samsung USB-C adapter is required to be attached. The phone should be presented to the music person with the file ready to play, phone in airplane mode and volume turned to maximum.

#### **REFUND POLICY:**

Entry fees will not be refunded after entry deadline unless no competition exists or the event is canceled. There will be no refunds for medical withdrawals.

# ADMISSION:

Admission to all events is free.

# FACILITIES:

The competition will be held at **Holiday Twin Rinks, 3465 Broadway, Cheektowaga, New York** (a suburb of Buffalo). Events will be conducted on a 85' x 200' rink. Snack bar and dressing rooms are available. Directions to the rink are available at: <u>www.holidayrinks.com</u>.

# LOCKER ROOMS AND CHANGING AREAS:

Locker rooms and changing areas at U.S. Figure Skating competitive events are for athletes only, will be labeled with regard to specific use and where identified will be gender specific. An exception can be made for athletes under 11 years old that will allow for one parent of the same sex to assist their child immediately prior to and after their skating event(s). Please review the Locker Room and Changing Area Policy in the <u>SkateSafe® Handbook</u>.

# U.S. Figure Skating Travel Policy:

All travel must strictly adhere to Two-Deep Leadership requirements. An Adult Participant cannot transport a Minor Athlete oneon-one and Two-Deep Leadership requirements must be adhered to at all times during In-Program travel, by transporting at least two minors or a second Adult Participant. An Adult Participant cannot share a hotel room or other sleeping arrangement with a Minor Athlete(s). ### **RESULTS:**

Results will be available at the registration event after each event for \$0.25 per copy for 6.0 events. A QR Code will be available and posted around the facility for live results online.

# SCHEDULE:

As soon as possible after the entry deadline, a TENTATIVE SCHEDULE will be posted on the Skating Club of Western New York web site: <u>www.skatingclubofwesternnewyork.org</u>. No scheduled times will be given out over the phone. No event conflicts will be adjusted prior to the event. If your skater has a conflict, please let the convenor know one hour before your event.

# PRACTICE ICE:

Unofficial Practice ice will be available on Saturday, May  $18^{th}$  and Sunday, May  $19^{th}$  at 7:00 a.m. There will be 2 - 25 minute practice ice sessions available at a cost of \$15.00 per session. One session will be for No-Test through Pre-Juvenile and one session will be for Juvenile through Adult. No music will be played during practice ice. Number of skaters per session is limited. Practice Ice can be purchased through Entryeeze, <u>http://comp.entryeeze.com/Home.aspx?cid=647</u>.

#### **REGISTRATION:**

Check-in will open at 6:30am Saturday, May 18<sup>th</sup> and Sunday, May 19<sup>th</sup>. The registration desk will be located at the main entrance to Holiday Twin Rinks and will be open throughout the competition. Competitors should register promptly upon their arrival.

**NOTE:** Skaters must be at the rink – and **READY TO SKATE** - at least **<u>1 HOUR BEFORE</u>** their scheduled event time. Events will not be delayed for late arriving skaters. This is a non-qualifying competition and events may run ahead or behind schedule.

If you are participating in a role requiring compliance, please be sure to <u>download or print your compliance card</u> to verify your compliance status on-site, if requested. If you believe your compliance card does not accurately reflect your compliance status, please contact <u>skatesafe@usfigureskating.org</u> at least 2 business days prior to the competition for assistance.

#### AWARDS:

Awards will be given for 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> places. Ribbons will be awarded for 4<sup>th</sup> and 5<sup>th</sup> places. Awards will be available immediately after the event has been posted and can be picked up at the awards table. There will also be award ceremonies throughout both days. The times will be listed at the registration table and throughout the rink.

#### VIDEO/PHOTO:

Personal videotaping may only be done from the stands with handheld cameras. No lights, tripods or taping permitted at rink side. For the safety of the skater – NO FLASH PHOTOGRAHY WILL BE PERMITTED.
